Chief Paul Courville reported on the calls and activity for the month of January.

#### TOWN ATTORNEY REPORT

Mr. Holmes reported that the Kinder Housing Authority recently consolidated with the Housing Authorities from Oberlin, Elton, and Basile. He explained that due to that consolidation, the U.S. Department of Housing and Urban Development (HUD) suggested starting over on the terms of the entire board. After some discussion, Mayor LaFargue appointed the following commissioners.

Mr. Holmes opened the discussion that was continued from the January 6<sup>th</sup> meeting in regard to adding a section related to UTV's to Ordinance No 832, known as the Golf Cart Ordinance. He explained that a UTV ordinance would be different than the current Golf Cart ordinance in that it would be state-wide and have different regulations. After some discussion, Mr. Holmes was asked to draft an ordinance to be introduced at the March 3, 2020 council meeting.
