**TOWN ATTORNEY REPORT**

Brennan Black, with Foley and Judell, was at the meeting to discuss proposed Ordinance No. 869, an ordinance authorizing the issuance of not exceeding Three Million Three Hundred Fifty Thousand Dollars (\$3,350,000) of Taxable Sales Tax Bonds (DEQ), Series 2021, of the Town of Kinder, State of Louisiana. After some discussion, Mr. Holmes opened the public hearing regarding Ordinance No. 869. There being no public comment, the public hearing was closed.
